27/09/2001

Formerly known as Japan Vietnam Medical Instrument Co., Ltd., JVC took its first step in the healthcare industry with 5 employees and a charter capital of VND 6 billion.

2002

JVC became the exclusive distributor of **Hitachi Healthcare's** diagnostic imaging products in Vietnamese market.

2007

In the same year, JVC became the distributor of **Fujifilm**, specializing in medical film and radiography products in Vietnam.

2010

On September 27th, 2010, Japan Vietnam Medical Instrument Co., Ltd. changed our name to Japan Vietnam Medical Instrument Joint Stock Company.

2011

JVC marked our 10th successful year with our IPO on Ho Chi Minh City Stock Exchange (Stock code: JVC) on June 21st, 2011 with 24.2 million shares.

At the same time, the company's charter capital increased from VND 242 billion to VND 322 billion.

2017

Establishing Ho Chi Minh City branch and relocating the headquarter to ICON 4 Building, 243A De La Thanh Street, Dong Da District, Hanoi.

2016

JVC became the distributor of **Sakura's** CSSD products in Vietnam.

2015

Increasing charter capital to VND 1,125 billion.

2014

JVC became the distributor of **Konica Minolta's** DR, CR, medical film and medical dry film printers in Vietnamese market.

2013

Increasing charter capital from VND 354 billion to VND 568 billion, marked the 3rd successful charter capital increase.

In the same year, JVC acquired Kyoto Medical Science Co., Ltd.

2012

Increasing charter capital from VND 322 billion to VND 354 billion.

2021

JVC converts the name from Japan Vietnam Medical Instrument Joint Stock Company to Japan Vietnam Medical Investment And Development Joint Stock Company to be more relevant to the areas the company will focus on in the future.

2022

JVC became the distributor of **B.Braun** in Vietnam.

2024

JVC became the distributor of **Terumo Neuro**, and **Baixiang**.

2025

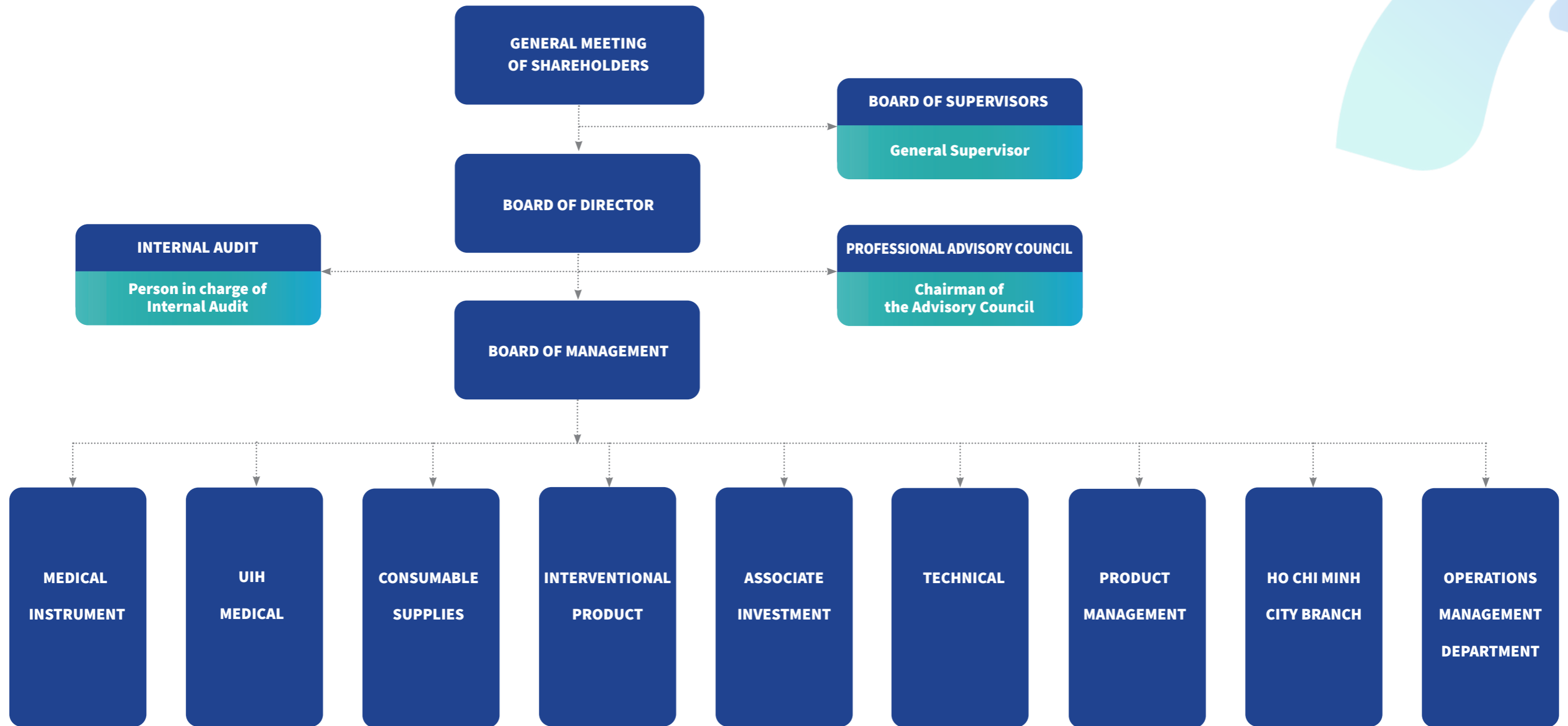
JVC became the distributor of **United Imaging** in Vietnam.

JVC expanded its business into the pharmaceutical sector and was subsequently renamed Vietnam Medical and Pharmaceutical Investment JSC (VMPI).

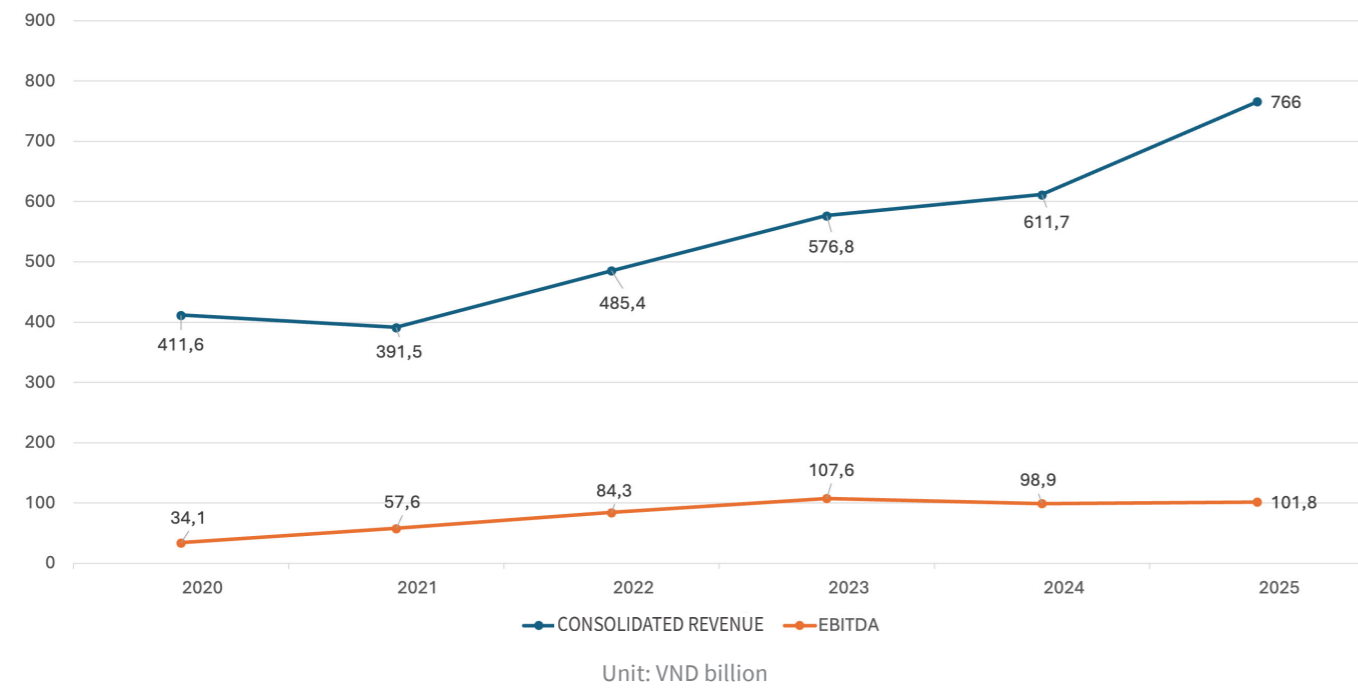

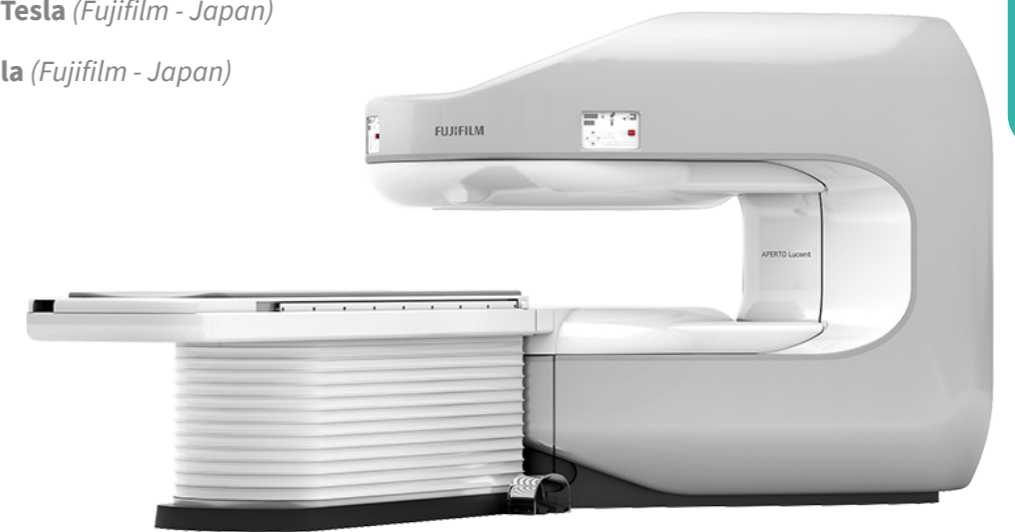

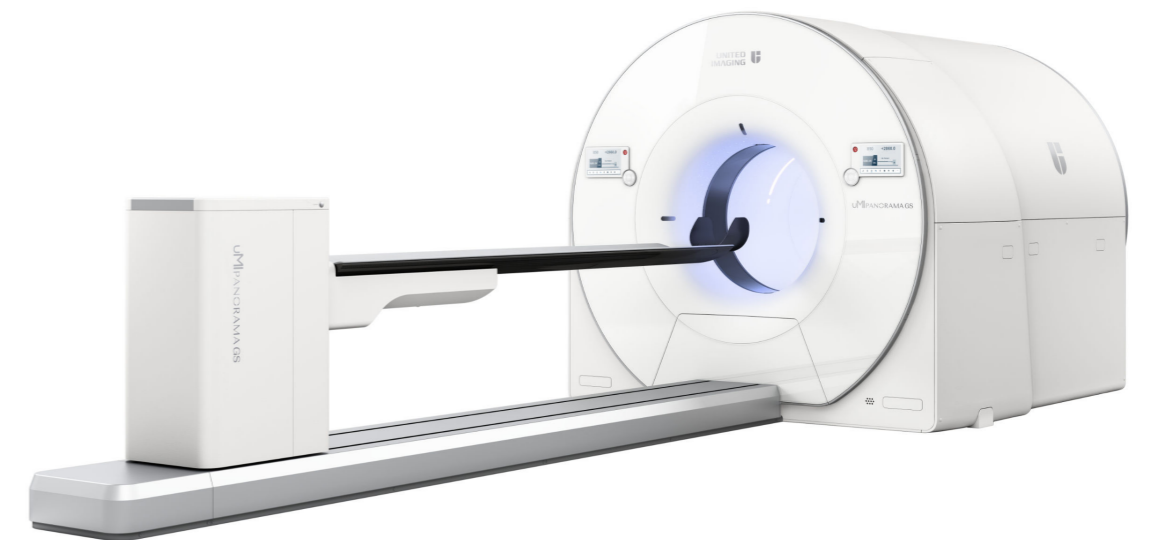

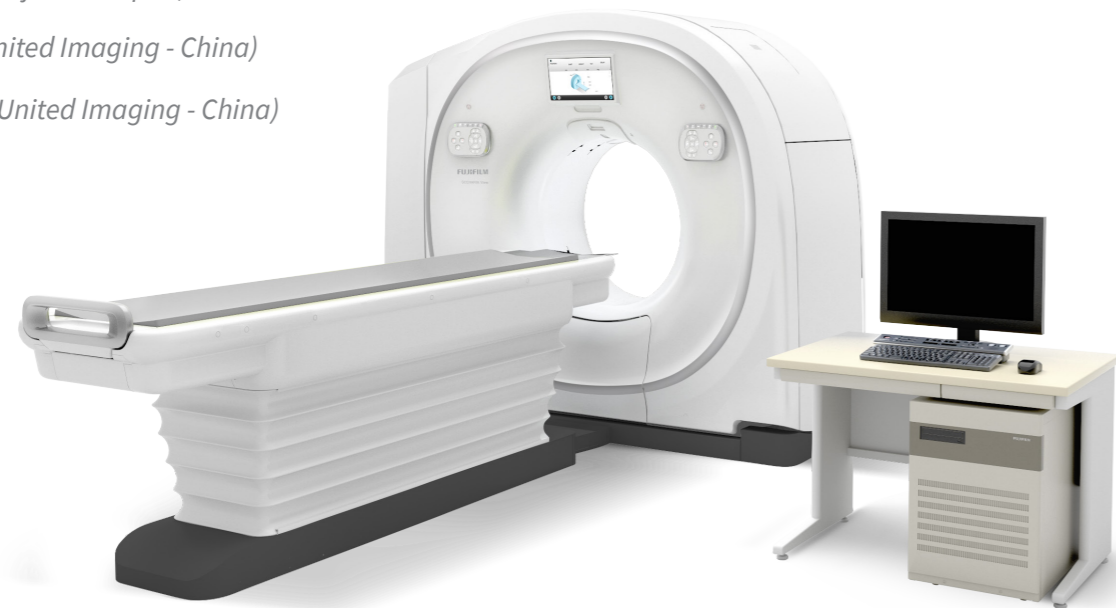

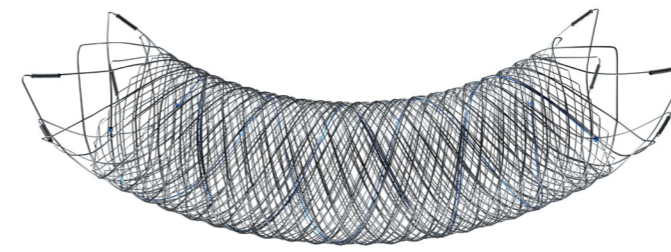
